**ARTICLE I**

Name

The name of the limited liability company is SCHRADER OIL CO. PROPANE, LLC (the "Company").

**ARTICLE II**

Period of Duration

The Company shall exist for thirty (30) years from the date of filing these Articles of Organization with the Secretary of State of the State of Colorado, unless sooner dissolved according to law.

**ARTICLE III**

Objects and Purposes

The Company is organized for any legal and lawful purpose pursuant to the Colorado Limited Liability Company Act, including (1) to engage in the acquisition, marketing, storage and sale of propane and other fuel products, (2) to develop, market and operate real estate investments, and (3) to carry on any business or activity related to or in connection with the foregoing, and (4) to have and exercise all of the powers, rights and privileges which a limited liability company organized under the Act may have and exercise.
