2. Contractor can access west side of ditch for construction, south along ditch from **Troutman Pkwy.** and west from **Westfield Dr.** along existing sidewalk. Any damaged or disturbed area is to be replaced by contractor (refer to GENERAL CONDITIONS, ARTICLE 6-- CONTRACTOR'S RESPONSIBILITIES, Use of Premises: 6.16.).
