2. **Second Reading of Ordinance No. 008, Determining and Fixing the Mill Levy for the Skyview South General Improvement District No. 15 for the Fiscal Year 2017; Directing the Secretary of the District to Certify Such Levy to the Board of Commissioners of Larimer County; and Making the Fiscal Year 2017 Annual Appropriation. (Adopted on Second Reading)**

*This Ordinance, unanimously adopted on First Reading on November 1, 2016, fixes the mill levy for the Skyview South General Improvement District No. 15 (GID No. 15) and authorizes the annual appropriation for 2017 of \$1,000 for the expenses of GID No. 15. The sum of \$29,700 is anticipated to be collected from the mill levy of 10.0 mills for fiscal year 2017 fixed in this Ordinance. Additional miscellaneous revenue for GID No. 15 of \$3,615 is anticipated to generated. The total 2017 revenue for GID No. 15 is expected to be \$33,315. The total amount will be used in the future to maintain and repair roads in the Skyview subdivision.*
