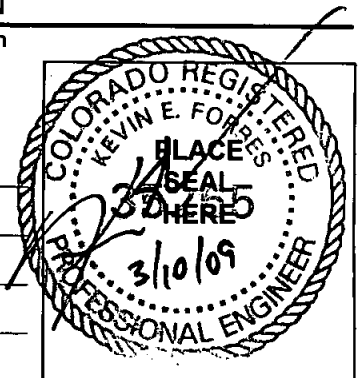

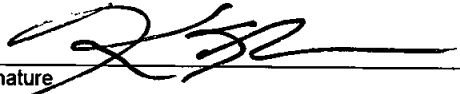

The addition has electric heat so there is no HVAC in the addition. 90% of the electrical lines are in the walls, a few electrical lines are under the floor in the floor joists. The additional crawl space under the addition is 432 sf with four 10" x 12" vents in the walls, two in the north wall and two in the west wall.

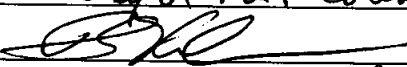
