**GENERAL DESCRIPTION**  
 The project is referred to as Verizon Wireless at 2555 S. Shields Street, #FDP130001. This is a request to construct wireless telecommunications antennas on the canopy roof over the loading dock on the west side of the existing Raintree Athletic Club. The antennas would be hidden inside a square screening enclosure designed to match the existing building. A separate equipment shelter would be constructed in a recessed area immediately north of the loading dock. The site is zoned N-C, Neighborhood Commercial. 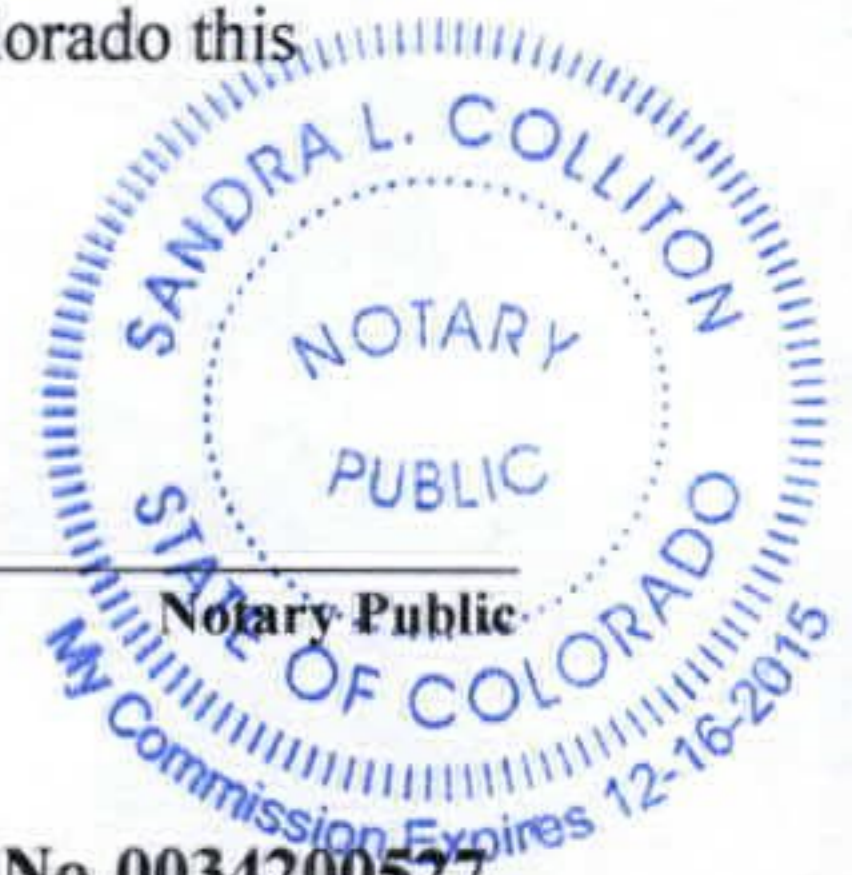
