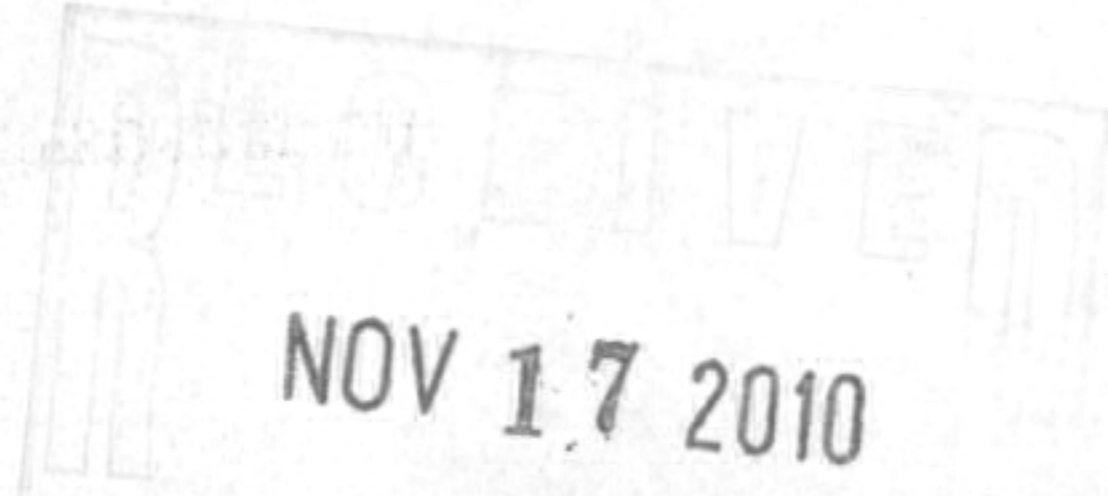

**NOTICE OF HEARING**

Notice is hereby given that on Monday, November 15, 2010, at 6:00 p.m., in conference rooms A-C, 281 North College Avenue, Fort Collins, Colorado, the City of Fort Collins Current Planning Department will conduct an Administrative Public Hearing to consider a development proposal in your neighborhood. The project is referred to as the South Transit Center, Project Development Plan #9-10.

**GENERAL DESCRIPTION**

This is a request for a "transit facility without repair or storage" to be located southwest of South College Avenue and Harmony Road, just south of the Spradley Barr dealership. The proposed development is on approximately 4.3 acres, directly adjoining the BNSF railroad and the Mason Corridor Trail. The site is in the Commercial (C) zone district. The site would be the south terminus of the Mason Street Corridor. Mason Street is proposed to extend to the site, from the north, along the railroad tracks. The Mason Street Extension will only be used by the rapid transit busses; users will access the site via Fossil Boulevard, or pedestrians can access the site via the existing Mason Corridor Trail that runs adjacent to the railroad tracks.

The proposal includes a 169 space "park-ride" lot, 11 bus bays and, a 4,253 square foot building. A north/south drive access is provided along the east side of the site, and will give the sites to the east and north access to Fairway Lane and South College Avenue and, will be the future location of a traffic signal. The proposal includes two Modification of Standard requests; one, to the "orientation to connecting walkway" standard, and the second modification request is to the "build-to" line standard.
