



NOTICE OF HEARING

Notice is hereby given that on Thursday, January 30, 2014, at 5:00 p.m., in Conference Room A, 281 North College Avenue, Fort Collins, Colorado, a Hearing Officer for the City of Fort Collins will conduct an Administrative Public Hearing to consider a development proposal.

GENERAL DESCRIPTION

The project is referred to as Cargill Expansion, combined Project Development Plan/Final Plan, file #FDP130043. This is a proposal to expand the existing Cargill campus, to include a 16,791 square foot office building with an attached 16,305 square foot warehouse, and an attached 9,386 square foot growth room. The project also proposes 81 parking spaces, 8 bike racks, and two additional greenhouses, each with 11,323 square feet. A new vehicle entrance, west of the existing entrance would be created. The existing entrance is to be gated for emergency access only. Modifications of Standard requests accompany this proposal. The site is located at 2540 East Drake Road, and is in the L-M-N, Low Density Mixed-Use Neighborhood zone district. 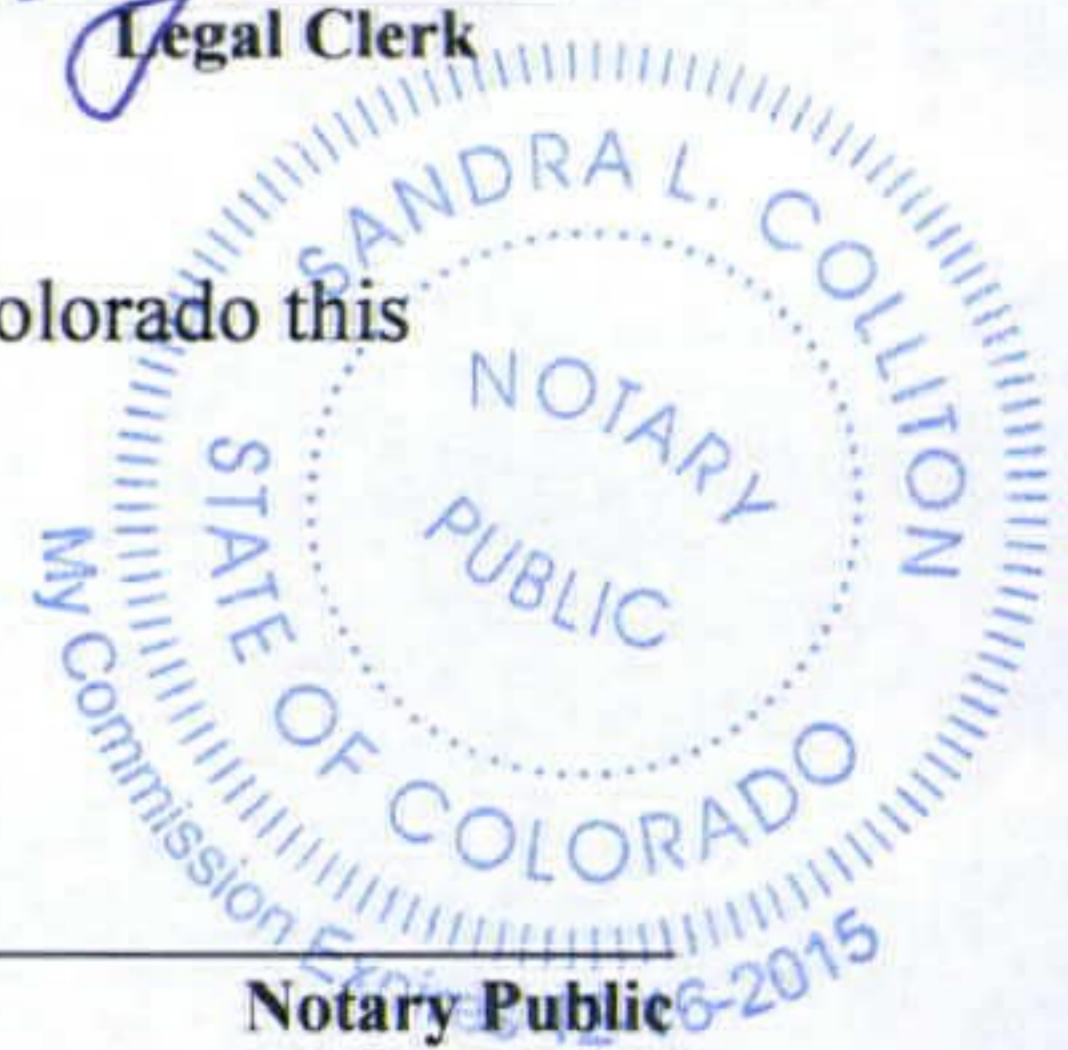
