



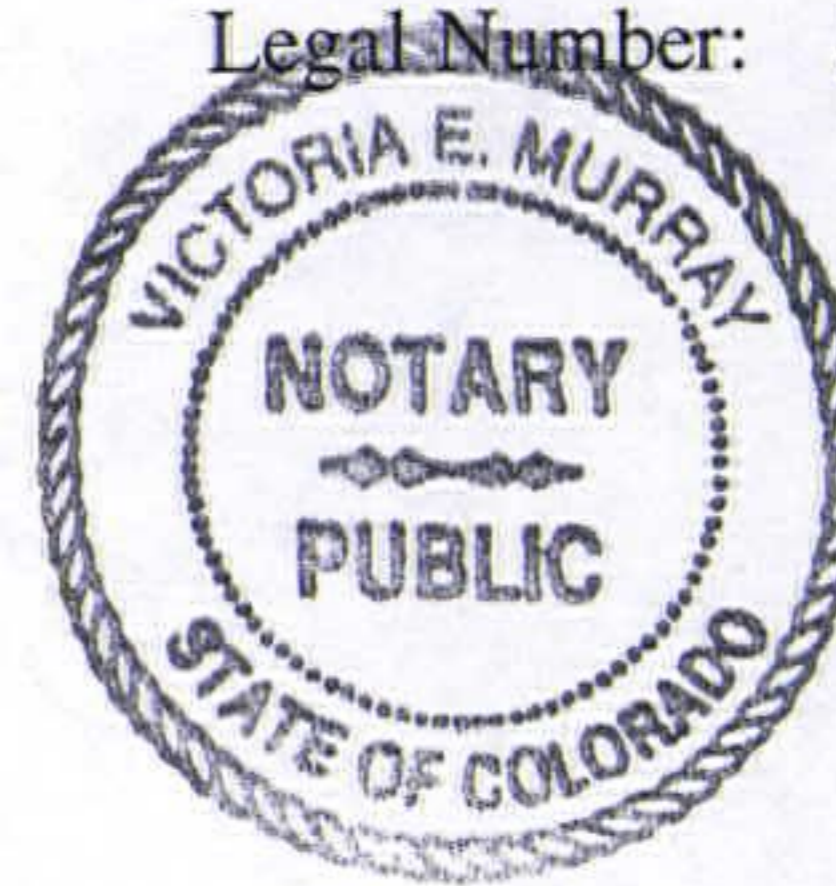

Notice is hereby given that on Monday, June 12, 2000, starting at 6:00 p.m., or as soon thereafter as the matter may come on for hearing in the Conference Room of the Current Planning Department, 281 North College Avenue*, Fort Collins, Colorado, the Administrative Hearing Officer will hold an Administrative Public Hearing to consider the Linden Park - P.D.P. #62-89. If approved, they shall create a Vested Property Right in accordance with Colorado Law.

GENERAL LOCATION:

Linden Park - Project Development Plan, request be for development of 38.20 acres of land into 201 residential dwelling units.
