NOTICE OF HEARING
 Notice is hereby given that on Wednesday, May 1, 2013, at 5:30 p.m., in Conference Room A, 281 North College Avenue, Fort Collins, Colorado, a Hearing Officer for the City of Fort Collins will conduct an Administrative Public Hearing to consider a development proposal.

GENERAL DESCRIPTION
 The project is referred to as the Stoner Subdivision, Project Development Plan, #PDP130005 with two Modifications of Standard. The proposed project is located at the southeast corner of Wayne and Magnolia Streets. This is a request to divide an existing 15,986 square foot lot located at 502 Wayne Street into two lots, and construct a one story single-family residence on a proposed new lot created to the east (Lot 2). An existing detached garage will remain on Lot 2 south of the new residence. An existing single family home would remain on the west lot (Lot 1). The project is located in the N-C-L, Neighborhood Conservation Low Density zone district, and is subject to an administrative (Type I) review. Two Modifications of Standard to the Land Use Code currently accompany the request. The first Modification addresses Section 4.7(F)(7), which states that no lot may be further subdivided to create a new lot in the rear portion of the existing lot. The second Modification addresses Section 3.6.2(J)(2), which requires that portions of alleys be paved in conjunction with this proposed use. The project proposes a lot subdivision and that the alley frontage remains unpaved. The project plans are available online for your review at: <http://www.fcgov.com/developmentreview/agendas.php>.

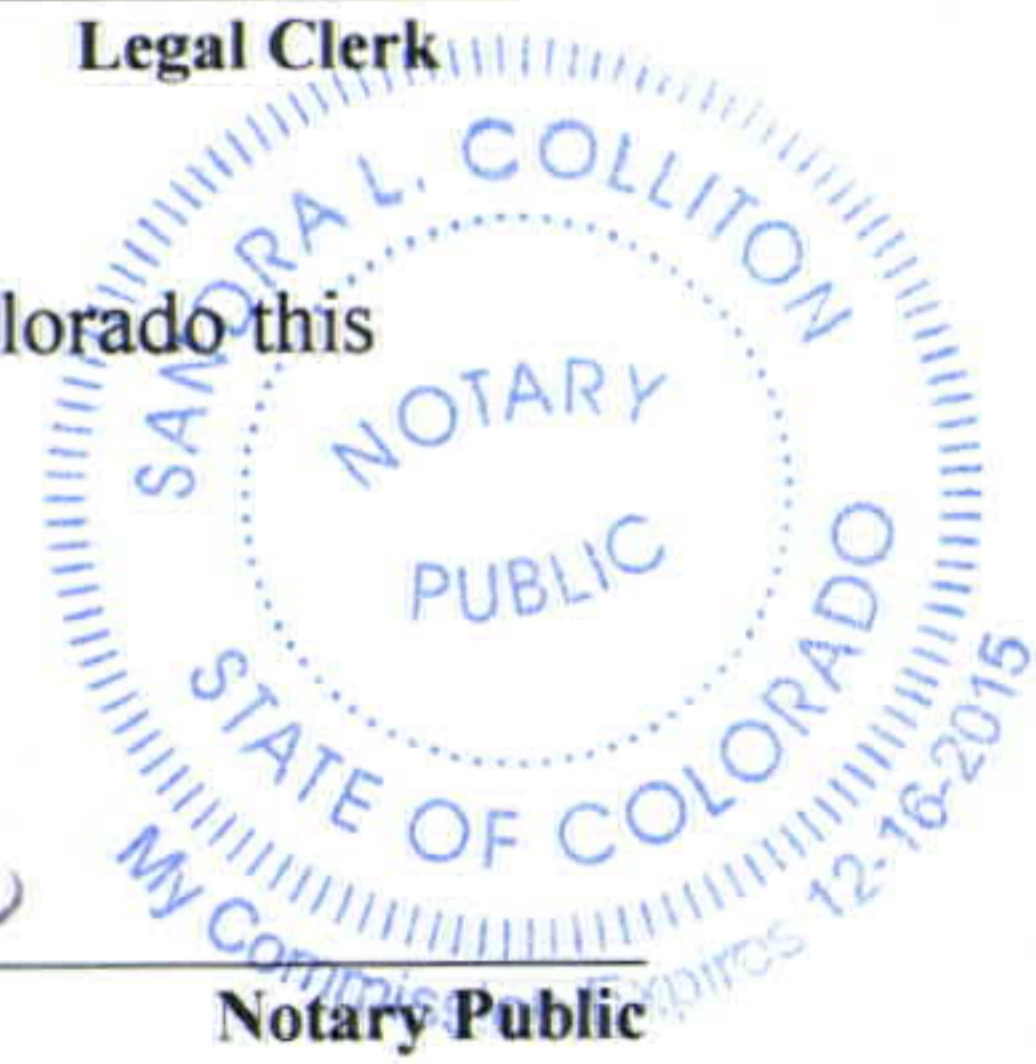
