Notice is hereby given that on Wednesday, May 14, 2014, at 5:00 p.m., in Conference Room A, 281 North College Avenue, Fort Collins, Colorado, a Hearing Officer for the City of Fort Collins will conduct an Administrative Public Hearing to consider a development proposal. This project will be the first item on the hearing agenda.

GENERAL DESCRIPTION

The project is referred to as Geico Office Building, Project Development Plan and Modification of Standard, file #PDP130039. This is a request for a 6,600 square foot, two-story building to be located at 2024 East Harmony Road. The proposed building uses are; office, medical office, and personal service shops. The site would include 26 parking spaces. The proposal includes a Modification request to Section 4.26(D)(1) Harmony Corridor Land Use Standards, for a distance reduction in the Harmony Road Setback Zone from 80 feet to 27 feet. 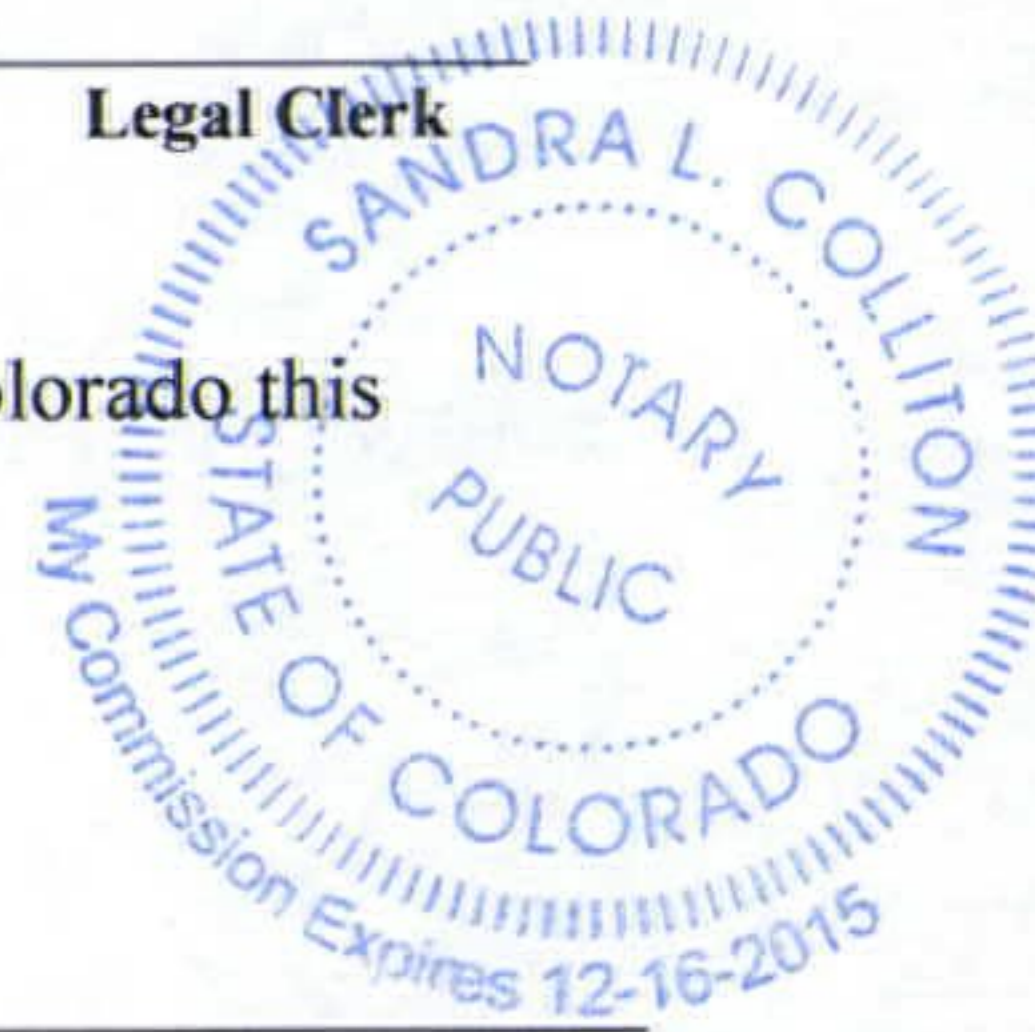
