**GENERAL DESCRIPTION**  
The project is referred to as Alta Vista Wireless Telecommunications Facility, file #PDP160028. The request proposes a 68' tall wireless telecommunications facility with a 2,000 sq. ft. footprint and a tower disguised as grain silo. The facility can accommodate up to three service providers. This site is located at 903 Buckingham St. just west of Lemay Ave. The property is in the Industrial (I) zone district. Wireless telecommunications facilities are permitted if approved by the Hearing Officer at a public hearing.
