

RESOLUTION 6917  
OF THE COUNCIL OF THE CITY OF FORT COLLINS GIVING  
PUBLIC NOTICE CONCERNING A PROPOSED ORDINANCE CHANGING  
THE ZONING MAP OF THE CITY OF FORT COLLINS AND AMENDING  
CHAPTER 19 OF THE CODE OF ORDINANCES OF THE CITY OF

KNOWN AS THE ZONING ORDINANCE

WHEREAS the City Council desires to hold a public hearing on said rezoning request as required by Section 19-21 1 (2) of the Code of Ordinances of the City of Fort Collins Colorado 1958 as amended

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FORT COLLINS that April 3 1969 at 1 30 P M or as soon thereafter as the matter may come on for hearing in the Council Chambers in the City Hall of the City of Fort Collins is hereby set as the time and place for a public hearing on said rezoning request and

BE IT RESOLVED FURTHER that the City Clerk is hereby instructed to publish a notice of said hearing as provided in Section 19-21 1 (2) of the Code of Ordinances of the City of Fort Collins Colorado 1958 as amended in the form attached hereto
