The previous memorandum mistakenly specified the addresses as Trestle Dr instead of Trestle Rd. For clarification it has been redistributed.

There has been a significant change to the addressing of the **Sidehill - Filing 2** plat (City of Fort Collins reference - S-252 #2433) and the **Sidehill - Filing 1** plat (City of Fort Collins reference - S-248 #2379). There were a couple of locations that had duplicate addresses between the plats and the **Sidehill - Filing 2** was addressed in the wrong north, south hundred block.
