SUBJECT

Resolution 2017-055 Making Appointments to the Air Quality Advisory Board, Citizen Review Board, Senior Advisory Board and Transportation Board of the City of Fort Collins.

EXECUTIVE SUMMARY

The purpose of this item is to appoint individuals to fill vacancies that currently exist on the Air Quality Advisory Board, the Citizen Review Board, the Senior Advisory Board and the Transportation Board due to resignations of board members. During the fall recruitment period applicants were selected to step into a future vacancy on the Transportation Board. Applications continued to be solicited for the Air Quality Advisory Board and the Senior Advisory Board. Council teams interviewed applicants for the Air Quality Board and the Senior Advisory Board during May.

STAFF RECOMMENDATION

Staff recommends adoption of the Resolution.

BACKGROUND / DISCUSSION

Section 2 of this Resolution makes an appointment to the Air Quality Advisory Board of Gregory Clark to a vacancy that was not filled during the fall recruitment; this term will expire on December 31, 2020. An appointment to the Citizen Review Board of Heather Gossel due to the resignation of Don Whitson, term to expire on December 31, 2017. An appointment to the Senior Advisory Board of Jason Brabson due to the resignation of Gosha Croiter, term will expire on December 31, 2017.
