This letter is meant to convey some important info, and to establish documentation. The following dates are the days I've been in transition or transferred to new facilities:

#1: Larimer County Detention Center → Denver Reception & Diagnostic Center on April 24<sup>th</sup>, 2017.

#2: Denver Reception & Diagnostic Center → Canon City, Cell House 5 (Court Transport Unit (C.T.U.)), located and attached to Territorial Prison on May 2<sup>nd</sup>, 2017.

#3: Cell House 5 → Crowley County Correctional Facility on May 15<sup>th</sup>, 2017.

The mailing address at C.C.C.F, Facility #6564, was STATE HWY 96, OLNEY SPRINGS, CO 81062-8700.

#4: Crowley County Correctional Facility → Cell House 5 on May 22<sup>nd</sup>, 2017.

The current mailing address is CTCF/CH5 → P.O. Box 1010 Canon City, CO 81215-1010.

The plaintive is pending transfer to an additional permanent facility, while waiting at CH5. The plaintive would also like to convey that he refused housing at Crowley County Correctional Facility, and spent the time of May 15<sup>th</sup>, 2017 to May 22<sup>nd</sup>, 2017 in the "HOLE," or Administrative Segregation. During this time, he was punitively punished, and was unable to inform the Court of the transfer. Four transfers in less than 30 days, and a pending Fifth transfer has caused an extreme hardship.

The Plaintiff also had scheduled Court Appearances in the 8<sup>th</sup> Judicial District, or Larimer County, on the mornings of May 23<sup>rd</sup>, 2017 and May 24<sup>th</sup>, 2017. The plaintiff WAS NOT "writted" back to L.C.O.C., and missed both appearances. He assumes these appearances will be rescheduled in the coming weeks, but the dates are unknown to him.

The Plaintiff has a scheduled jury trial on June 19<sup>th</sup>, 2017, and/or June 20<sup>th</sup>, 2017, and is to last 4-5 days until approximately June 23<sup>rd</sup>, 2017. The assumption is that plaintiff will be writted at least once, possibly twice in the month of June 2017.

AND FINALLY, the Plaintiff would like to inform the residing Judge that he HAS NOT yet to date received any correspondence from the Court in connection to his AMENDED PRISONER COMPLAINT that was mailed, or submitted to Cell House 5 to be mailed on May 7<sup>th</sup>, 2017. The plaintiff assumes the 2-PART A.P.C. was processed and mailed between May 8<sup>th</sup> → May 12<sup>th</sup>. He has received NO NEW ORDERS, and is unaware if there is a new 30-day order. The plaintiff would like to comply with Court orders in a timely and effective matter, but has not yet received any new legal mail from this Court since May 7<sup>th</sup>. This amounts to  $\approx$  17 days w/ NO NOTICE.

Attached to this letter are Four Forms: AR Form 750-01A, AR Form 750-01A (#2), Case Manager Kite, and CTCF Form 300-381. CTCF Form 300-381 documents date and time of the submitting of A.P.C. to be mailed. The two AR Form 750-01A's show facility responses to Plaintiff. The Plaintiff has submitted one yellow DC Form 750-01E, and received on May 8<sup>th</sup>, 2017 → 1 Manila envelope, 10 blank copy paper, and one very generic cover page. He is submitting another on May 24<sup>th</sup>, 2017.

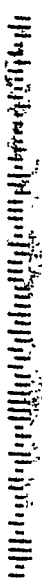

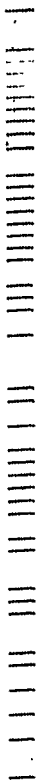
