Therefore, the court orders as follows:

1. That the person named in this order is in custody for the purpose of obtaining the non-testimonial identification above set forth and described in the affidavit attached;
2. That the said non-testimonial identification procedures specified herein be conducted expeditiously, and after such identification procedures have been completed, the person named in this order shall be released back to custody or charged with an offense;
3. That the person named in this order shall be detained for only such time as is reasonably necessary to obtain the non-testimonial identification specified herein;
4. That this order may be executed and returned only within fourteen days from the date hereof;
5. That this order shall be executed immediately due to Chayce Aaron Anderson being detained;
6. That the officer executing the order shall give a copy of this order to Chayce Aaron Anderson;
7. That no search of Chayce Aaron Anderson be made, except a protective search for weapons;
8. That a return of this order shall be made to the undersigned judge showing whether Chayce Aaron Anderson has been detained for such non-testimonial identification and whether the said person was released or charged with an offense;
9. This order is issued pursuant to Colorado Rules of Criminal Procedure 41.1.
