This matter is before the Court on Plaintiff's response to the Court's case status order dated January 14, 2019 regarding service of process with regard to Logan Simpson Design. In response to the Court's order Plaintiff has clarified that she has not identified Logan Simpson Design as a separate Defendant in this matter. 
