

Mr. Wiemold, the Appellant, requested a transcript of Fort Collins Municipal Court case 2018-0240752-MD. A payment for the transcripts was received by Fort Collins Municipal Court on or about October 7<sup>th</sup>, 2019, in the amount of \$335. On November 18<sup>th</sup>, 2019, the Municipal Court Administrator was notified via email from *Blue Bird Transcripts*, that the transcriber would need additional time to finish the requested transcription, due to the length of case, and workload (a copy of which was sent to Appellant Attorney Adam Frank). The Municipal Court Administrator was again notified via email on December 11<sup>th</sup>, 2019, that the transcriber assigned to Mr. Wiemold's case needed to address some personal family matters, and had not yet completed the transcription (a copy of which was again sent to Attorney for Appellant, Adam Frank). The Deputy Court Administrator contacted Blue Bird Transcripts on December 23, 2019 for a status update but has yet to receive a response. I am unable to prepare the Notice of Completion of Record for review by the defendant and the City Attorney's Office until the audio files are transcribed. The Municipal Court will be obtaining a new transcriber to complete the requested files.
