I am also returning the first two contracts that they signed to you that were unacceptable. You can do with as you please with these.

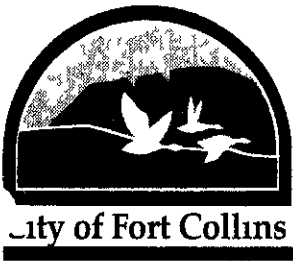
