Prices indicated are minimums estimated for art and sign production only. Delivery and/or installation are not included unless specifically stated on invoice. Changes and/or additions caused by the customer, special consultations, permit fees, packing, shipping, and all other work expenses that can not be estimated accurately in advance will be billed as extra unless specified herein.
For installation of electrical signs, price does not include materials or labor to run wiring to the sign location, to purchase and/or install photo eyes or time clock devices, and final electrical connections unless specified herein.

Unexpected charges arising from removal of old signs and/or installation of customer's signs will be billed separately. Customer is responsible for disposal of old signs and sign components. Dismantling, disposal and environmental impact fees will be charged for any old signs or sign parts removed from the worksite.

Terms of Payment: 100% prepayment is due on orders under \$200. A 50% deposit is due on orders over \$200 with the balance due upon delivery, pickup, or installation. Commercial accounts with credit terms are subject to Signarama's approval.

Customer's acceptance, either in person or through his/her agent(s) and/or employee(s) of the work shall be deemed as full acceptance. By accepting delivery and/or installation of the work, customer affirms that all work substantially conforms to all expectations.

Collection procedures: Invoices are considered delinquent thirty (30) days from the date that your order is completed. After the thirtieth day, a late charge of \$25.00 together with interest accruing at 1.5% per month will be added to your invoice. You shall be liable for all costs related to collection of delinquent invoices, including court costs and attorney's fees.

Lost or Forgotten Work: If customer does not take possession of completed work within thirty (30) days from notification of completion, then the work will be considered lost or forgotten, and SIGNARAMA will not be responsible for further loss. Customer will be billed and responsible for payment for all work that has been completed.

Sign-A-Rama retains the right to all artwork and designs until paid in full. All signs remain the property of Sign-A-Rama until final payment is cleared. Warranties for both product and labor are offered in writing only. By signing and/or approving this quotation you have authorized Sign-A-Rama to enter your premises to remove signs if the balance is not paid in full within terms established.

Please note that your balance is due upon completion unless payment terms are arranged in advance.
