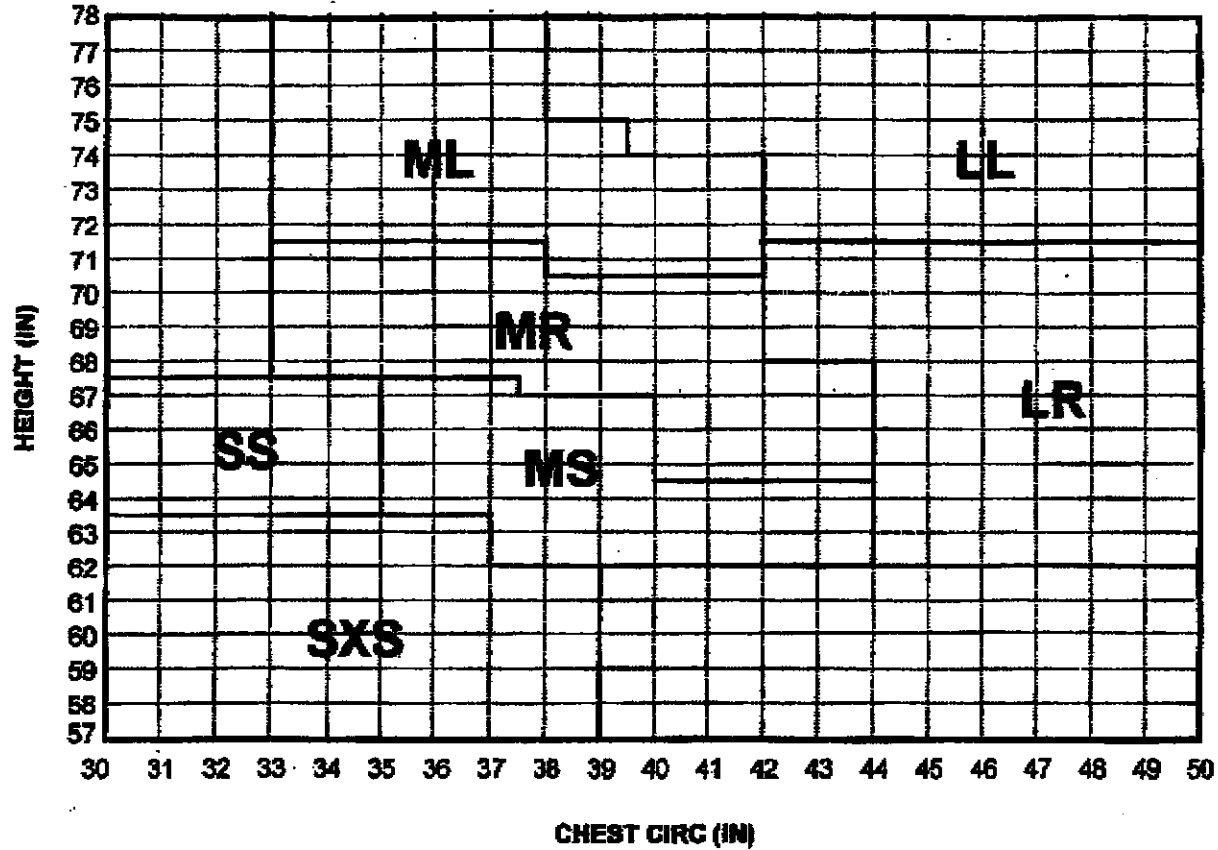

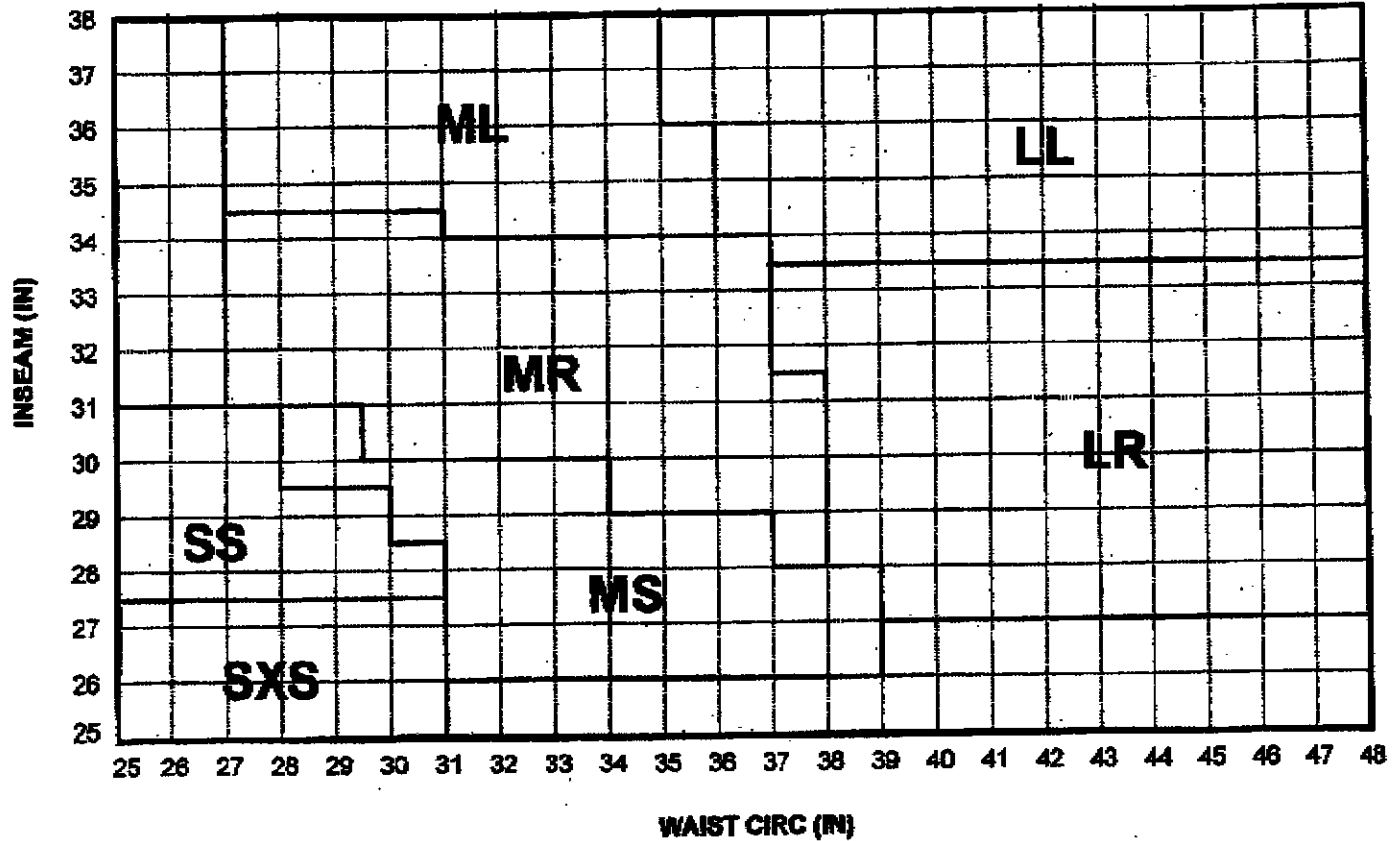

LANX Fabric Systems Chemical Protective Overgarment Trousers Size Selection Chart

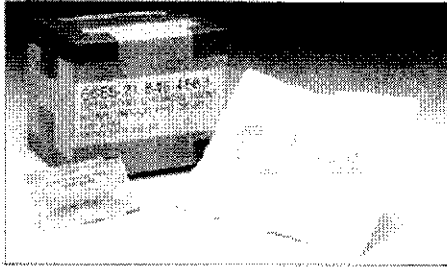
