Notice is hereby given that on Thursday, January 30, 2014, at 5:00 p.m., in Conference Room A, 281 North College Avenue, Fort Collins, Colorado, a Hearing Officer for the City of Fort Collins will conduct an Administrative Public Hearing to consider a development proposal. The project is scheduled as third on the agenda.

GENERAL DESCRIPTION

The project is referred to as Nathan's Subdivision, 637 Cowan Street, combined Project Development Plan/Final Plan, file #FDP130030. This is a request to remove the existing single family home and detached garage located at 637 Cowan Street and replat the 10,900 square foot lot. The re-platted lots will contain over 5,000 square feet each, allowing a detached single family building with a driveway to be constructed on each lot. 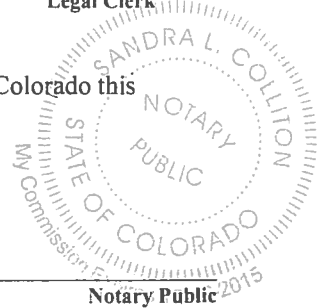
