NOTICE OF HEARING

Notice is hereby given that on Thursday, June 26, 2014, at 5:30 p.m., in Conference Room A-D, 281 North College Avenue, Fort Collins, Colorado, a Hearing Officer for the City of Fort Collins will conduct an Administrative Public Hearing to consider a development proposal.

GENERAL DESCRIPTION

The project is referred to as Avondale Cottages, file #PDP140003. This is a request for a residential development of 10 small single family homes with 27 parking spaces, situated on a 1.5 acre site. The proposal is a qualified Habitat for Humanity Affordable Housing project, located at the southeast corner of Avondale Road and Trilby Road. The site would be accessed from Avondale Road, via a shared drive on the north side of the Little People's Learning Center. The existing landscaping along Trilby Rd. and Avondale Rd. would remain. 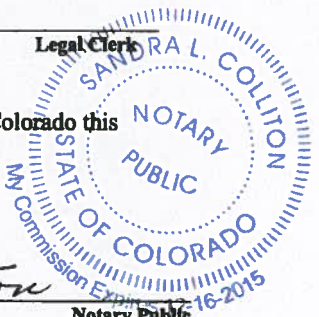
