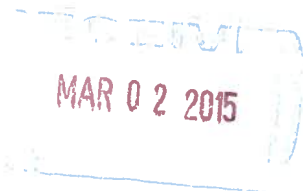

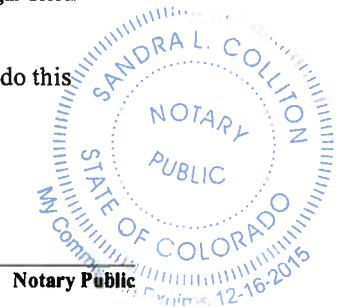

NOTICE OF HEARING

Notice is hereby given that on Thursday, March 5, 2015, at 5:00 p.m. (scheduled as the second item on the agenda) in Conference Rooms A-D, 281 North College Avenue, Fort Collins, Colorado, a Hearing Officer for the City of Fort Collins will conduct an Administrative Public Hearing to consider a development proposal.

GENERAL DESCRIPTION

The project is referred to as Registry Ridge Filing Seven, Project Development Plan, file #PDP140020. This is a request to replat a portion of the existing Registry Ridge Filing 2, and all of Filing 4. The project proposes 56 single-family attached dwellings (townhomes), and 18 single-family detached dwellings. The gross density is 6.27 dwelling units/acre, and 20 percent of the site would be open space. The project is located southwest of Trilby Road and South Shields Street, and is zoned (L-M-N) Low Density Mixed-Use Neighborhood.
