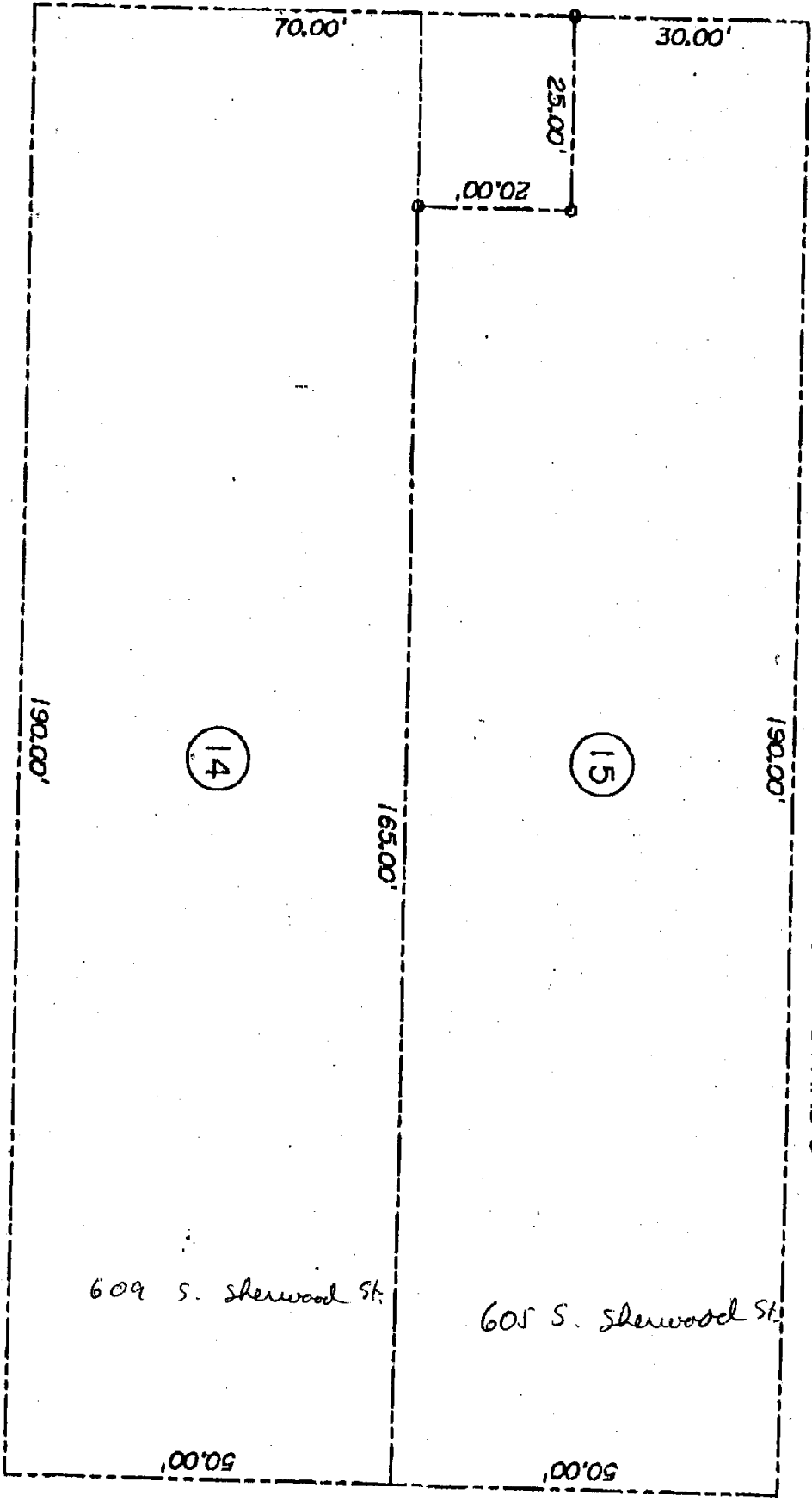


20' WIDE ALLEY

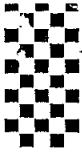
