

ORDINANCE NO 1 1932,
BEING AN EMERGENCY ORDINANCE AUTHORIZING THE ISSUANCE OF FOUR PER
CENT REGISTERED WARRANTS NOT TO EXCEED THE TOTAL AMOUNT OF \$1600 00,
ON ACCOUNT OF AN EMERGENCY ARISING IN CONNECTION WITH THE INVESTIGA-
TION OF A MUNICIPAL LIGHT AND POWER PLANT


WHEREAS, since the adoption of the annual appro-
priation ordinance for the fiscal year ending December 31 1932
an emergency and unforeseen contingency has arisen whereby it
has become and is necessary to pay not to exceed the sum of
\$1600 00 on account of investigation concerning a municipal
light and power plant for the City of Fort Collins and the
public necessity requires an additional appropriation of public
funds therefor

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL
OF THE CITY OF FORT COLLINS

Section 1 That there be and hereby is appro-
priated out of the general revenues of the City of Fort Collins
for the year 1933 or subsequent years, as may hereafter be directed
by the City Council unless taken up prior thereto, the sum of
\$1600 00 on account of the investigation concerning a municipal
light and power plant and registered four per cent warrants of
the City shall be issued to cover the amount required therefor
not to exceed the sum of \$1600 00 the denomination of said
warrants to be as directed by the Commissioner of Finance

Section 2 In the opinion of the City Council
an emergency exists for the preservation of the public health,
peace and safety, and this Ordinance shall take effect upon its
passage and publication, under and by virtue of the authority
contained in Sections 6 and 7 of Article IV of the City Charter
