

ORDINANCE NO 1929
BEING AN EMERGENCY ORDINANCE AUTHORIZING THE ISSUANCE OF FIVE
PER CENT REGISTERED WARRANTS IN THE AMOUNT OF \$ 13,536.60
FOR MUNICIPAL RAILWAY EMERGENCY FUND

WHEREAS, Since the adoption of the annual appropriation ordinance for the fiscal year ending December 31st, 1929, an emergency and unforeseen contingency has arisen whereby it has become and is necessary to pay Thirteen thousand five hundred thirty-six and 60/100 (\$ 13,536 60) Dollars for the purpose of paying Municipal Railway Emergency expense and the public necessity requires an additional appropriation of public funds therefore

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT COLLINS

Section 1 That there be and hereby is appropriated out of the general revenues of the City of Fort Collins for the years 1930 1931, 1932 1933 1934, 1935 1936 and 1937 unless taken up prior thereto the sum of Thirteen thousand five hundred thirty-six and 60/100 (\$ 13,536.60) Dollars, one-eighth of said amount together with all accrued interest thereon, to be paid each of said years beginning in 1930 to be used to pay for Municipal Railway Emergency expense, which said sum, when this ordinance takes effect shall be credited on the books of the City Clerk and City Treasurer to Municipal Railway Emergency Fund and registered five (5%) per cent warrants of the City of Fort Collins shall be issued to cover said amount

Section 2 In the opinion of the City Council an emergency exists for the preservation of the public health peace and safety, and this ordinance shall take effect upon its passage and publication,

under and by virtue of the authority contained in Sections 6 and 7 of Article IV of the City Charter
