

ORDINANCE NO 26, 1923

BEING AN EMERGENCY ORDINANCE FIXING AND ESTABLISHING THE GRADES ON SOUTH WHITCOMB STREET FROM THE SOUTH CURB LINE OF OAK STREET TO THE NORTH CURB LINE OF LAUREL STREET IN THE CITY OF FORT COLLINS, COLORADO

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT COLLINS

Section 1 The grades for South Whitcomb Street from the south curb line of Oak Street to the north curb line of Laurel Street are hereby fixed and established and declared to be as follows

All center line grades shall be raised six-tenths of a foot above those given for dirt or gravel improvement

All elevations are referred to City Datum B M 104 76 at the intersection of the walks on the corner of College Avenue and Oak Street at the postoffice corner



Section 2 All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed

Section 3 In the opinion of the City Council an emergency exists for the preservation of the public health, peace and safety, and this ordinance shall take effect upon its passage and publication under and by virtue of the authority contained in Sections 6 and 7 of Article IV of the City Charter


