

ORDINANCE NO 13, 1923

BEING AN EMERGENCY ORDINANCE FIXING AND ESTABLISHING THE GRADES ON NORTH SHERWOOD STREET BETWEEN WEST MOUNTAIN AVENUE AND MAPLE STREET AND ALSO FIXING AND ESTABLISHING THE GRADES ON WEST STREET BETWEEN LAPORTE AVENUE AND CHERRY STREET, IN THE CITY OF FORT COLLINS, COLORADO

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT COLLINS

Section 1 The grades for North Sherwood Street between West Mountain Avenue and Maple Street, extending from the North property line of North the intersection of Sherwood Street with West Mountain Avenue to the intersection of the South property line of Maple Street with North Sherwood Street, are hereby fixed and established and declared to be as follows:

All elevations being referred to City Datum B M. 104 76, at the intersection of the walks on the corner of College Avenue and Oak Street, at the postoffice corner

At the north property line of Mountain Avenue, center line 119 92, west walk line 120 55, west curb line 119.75, east walk line 120 12, east curb line 119 59, at station 2 plus 00, center line 118 80, west walk line 119 33, west curb line 119 00, east walk line 119 00, east curb line 118 67, at the south property line of Laporte Avenue, center line 111 82, west walk line 112 44, west curb line 111 93, east walk line 111 90, east curb line ~~111 99~~ 111 86, at the north property line of Laporte Avenue, center line 111 43, west walk line 111 85, west curb line 111 48, east walk line 111 70, east curb line 111 48, at the south property line of Maple Street center line 109 95, west walk line 110 33, west curb line 110 00, east walk line 110 33, east curb line 110 00

Section 2. The grades for West Street between the north property line of Laporte Avenue and the south property line of Cherry Street at the intersection of Cherry Street with West Street, are hereby fixed and established and declared to be as follows

All elevations being referred to City Datum B M 104 76, at the intersection of the walks on the corner of College Avenue and Oak Street, at the postoffice corner.

Elevation of center line at the north property line of Laporte Avenue, Station 6 plus 77, 138 30, west walk line 138,64, west curb line 138 41, east walk line 138 64, east curb line 138 41, at station 9 plus 40, center line 139 60, west walk line 140 08, west curb line 139 85, east walk line 139 31, east curb line 139 10, at the south ptoperty line of Maple Street, center line 143 15, west walk line 143 48, west curb line 143 25, east walk line 143 27, east curb line 143 04, at the north property line of Maple Street where the same intersects West Street, center line 143 15, west walk line 143 48, west curb line 143 25, east walk line 143 24, west curb line 143 01, at the south property line of Cherry Street where the same intersects West Street, center line 140 42, west walk line 140 58, west curb line 140 35, east walk line 140 58, east curb line 140 35

Section 3 All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed

Section 4 In the opinion of the City Council an emergency exists for the preservation of the public health, peace and safety, and this ordinance shall take effect upon its passage and publication under and by virtue of the authority contained in Sections 6 and 7 of Article IV of the City Charter
