

ORDINANCE NO 6 1919

BEING AN EMERGENCY ORDINANCE FIXING AND ESTABLISHING GRADES  
FOR STOVER STREET IN THE CITY OF FORT COLLINS COLORADO

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FORT COLLINS

Section 1 The grades for Stover Street in the  
City of Fort Collins are hereby fixed and established and  
declared to be as follows

All elevations being referred to City Datum B M 104 76  
at the intersection of walks on the corner of College Avenue  
and Oak Street at the postoffice corner


Beginning at station minus 200 which is 200 feet north  
of station 0, the north property line of Magnolia Street,  
elevation on the east sidewalk line 85 2, at the center line  
of street 85 2, at the west sidewalk line 85 5, at station 0  
the north property line of Magnolia Street on the east  
sidewalk line 84 64, at the center line of street 84 64, at  
the west sidewalk line 84 94, on the south property line of  
Magnolia Street at the east sidewalk line 84 74, at the  
center line of street 84 74, at the west sidewalk line 85 04,  
on the north property line of Mulberry Street at the east  
sidewalk line 86 66, at the center line of street 86 66, at  
the west sidewalk line 86 96, on the south property line of  
Mulberry Street at the east sidewalk line 87 09, at the  
center line of street 87 09, at the west sidewalk line 87 29,  
on the north property line of Myrtle Street at the east  
sidewalk line 88 61, at the center line of street 88 61, at  
the west sidewalk line 88 91, on the south property line of  
Myrtle Street at the east sidewalk line 89 20, at the center  
line of street 89 20, at the west sidewalk line 89 50, on

Section 2 All ordinances and parts of ordinances in  
conflict with this ordinance are hereby repealed

Section 3 In the opinion of the City Council an  
emergency exists for the preservation of the public health  
peace and safety and this ordinance shall take effect upon  
its passage and publication under and by virtue of the  
authority contained in Sections 6 and 7 of Article IV of the  
City Charter
