

Ordinance No 8 1895

Amending Section One of Ordinance No 1 1891 Relating to Streets, alleys and Public Grounds.

Be it ordained by the City Council of the City of Fort Collins

Section 1 That Section one of Ordinance No one 1891

Relating to Streets alleys and Public Grounds be and

the same is hereby amended so as to read as follows.

Sec. 1 It shall be unlawful for any person or persons

in any manner to encumber or obstruct any street alley,

sidewalk or public ground within the corporate limits of the city of

Fort Collins or erect any buildings in whole or in part, upon any

street alley sidewalk or public ground, or make excavations holes

ditches or do any other thing to or upon any street alley side-

walk or public ground that may endanger the safety of the

public within said city, provided however that permission

may be granted by the Mayor to any contractor or builder, ~~owner~~

owner or other persons to occupy a part of any

street within the said city not to exceed one half of the street

on front of the lots or lots upon which any ^{such} contractor, builder, owner

or other persons is erecting or is about to erect or construct any

building ~~improvement~~ or doing other work or making any

improvement for a period not to exceed thirty (30) days and

such permission may also be granted to any person to excavate

in the street ^{or} alleys for the purpose of laying ^{and} connecting sewers ^{and} drains

or water pipes for private connections but no such permission

shall be granted for any of the purposes above specified unless

application shall be made therefor to the Mayor and such

permission ^{granted and} be executed in the following form and

upon the following express conditions contained therein.

City of Fort Collins Colorado

Permit for occupation or excavation in street

Permission is hereby granted to

of said city to occupy or excavate.

Street for a period not to exceed thirty (30) days from the date hereof, and upon the following express conditions, that in case of occupancy of said street for building purposes or other improvement that proper guard rails shall be constructed and maintained around the material occupying the street during the entire period of such occupancy and in the event of excavation that the person obtaining the permit, will maintain signal lights at all points of danger and keep and maintain such lights, ^{burning all of} each and every night during such excavation until all danger is removed, and provided further the permit is issued upon the express condition that the person to whom it is granted will in all respects restore the street to its former condition before such occupancy or excavation.

 And it shall be the duty of the City Clerk to have the said permit printed and bound in book form with an appropriate stub so that he can at all times advise the City Council of all permits outstanding under the provisions of this ordinance, and any failure to observe each and every provision of this section shall subject the offender person or persons so offending to the penalties ~~also~~ ^{provided} provided in section seven ⁽⁷⁾ of this ordinance.
