

RESOLUTION 93-174
 OF THE COUNCIL OF THE CITY OF FORT COLLINS
 ESTABLISHING AND REVISING FEES TO BE CHARGED
 FOR RECREATION DIVISION PROGRAMS

WHEREAS, pursuant to Section 23-114 of the Code of the City of Fort Collins, the City Council is authorized to lease interests in real property owned in the name of the City, provided Council first finds, by resolution, that the lease is in the best interest of the City; and

WHEREAS, the following rate schedule for the lease of recreation facilities will generate revenue to help offset the cost of owning and operating the recreation facilities.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FORT COLLINS as follows:

Section 1. That the City Council finds that the lease of the City's recreation facilities, on the terms and conditions described in Section 2 below, is in the best interests of the City and hereby authorizes the lease of these facilities.

Section 2. That the following rate schedule shall be in effect for the lease of the recreation facilities, commencing January 1, 1994:




