- ✓ • IS THERE AN EASEMENT NEEDED FOR THE JOSH AMES DITCH ACROSS THIS PROPERTY. THE DITCH COMPANY WILL NEED TO SIGN THE PLAN.
- ✓ • THERE IS A NOTE THAT SAYS APPROXIMATE CENTERLINE LAKE CANAL BUT NO ARROW INDICATING WHERE THAT IS. IS IT ON THE PROPERTY LINE? IS AN EASEMENT NEEDED ON THIS PROPERTY FOR THE DITCH. IF THE DITCH IS ON THIS PROPERTY THAN THE LAKE CANAL WILL NEED TO SIGN THIS PLAT.
