Resolution 2019-089 Making an Appointment to the Northern Colorado Regional Airport Commission.

EXECUTIVE SUMMARY

The purpose of this item is to appoint Jerry Stooksbury to the Northern Colorado Regional Airport Commission.

STAFF RECOMMENDATION

Staff recommends adoption of the Resolution.

BACKGROUND / DISCUSSION

On January 6, 2015, Council adopted Resolution 2015-002 adopting the Airport Strategic Plan, and Resolution 2015-003 authorizing the Mayor to Execute an Amended and Restated Intergovernmental Agreement (IGA) between the owners of the Airport, the cities of Fort Collins and Loveland.

As part of the Strategic Plan, a seven-member Commission was created. The Commission includes one "Joint Citizen Member" appointed by the cities of Fort Collins and Loveland. Mr. Stooksbury was previously appointed as the "Joint Citizen Member" by City Council's adoption of Resolution 2015-058 on June 2, 2015, for a term that expired on June 30, 2019.

This Resolution reappoints Jerry Stooksbury as the "Joint Citizen Member." Mr. Stooksbury was appointed by the Loveland City Council on August 6, 2019, by Resolution #R-82-2019.

The Joint Citizen Member will serve a term commencing immediately and extending through its expiration at the end of June 30, 2023.

1)	Strategic Planning. We need continued focus on a strategic development plan to benefit the airport and community. At times in the past this has been too tactically driven. Recently we have started using an overall map of the area. The next step is to clearly identify zones/areas on the airport for the future terminal, a technology business park, and an aviation business area (FBO, aircraft maintenance, MRO, transient aircraft parking and hangar, executive hangar area, etc. Some of these elements already exist in places, but we need a plan and a development map to tie it all together.			
2)	Business development. We need to explore new ways to encourage development of existing and new aviation-oriented businesses at our airport. Existing businesses should be invited to the commission meetings and asked specifically what they would like/need in order to grow their businesses significantly. Separately, the commission needs to target new businesses for the technology park and work with local entities for public/private partnerships for the develop of the infrastructure as well as recruiting the businesses.			
3)	Airline service. The airport needs to continue its efforts in this regard and work with local business leaders to develop a plan for revenue guarantees in order to get airline service re-established. The right local business support matched with the airlines the provide the right route service to better serve theses businesses and their employees could be the winning combination to get one or more airlines serving our airport again.

RESOLUTION 2019-089 OF THE COUNCIL OF THE CITY OF FORT COLLINS MAKING AN APPOINTMENT TO THE NORTHERN COLORADO REGIONAL AIRPORT COMMISSION

WHEREAS, on January 6, 2015, City Council adopted Resolution 2015-002 adopting the Fort Collins-Loveland Airport Strategic Plan; and

WHEREAS, on the same date City Council adopted Resolution 2015-003, authorizing the Mayor to execute an Amended and Restated Intergovernmental Agreement (the "IGA") between the Cities of Fort Collins and Loveland (the "Cities") as the owners of the Fort Collins-Loveland Municipal Airport (the "Airport"); and

WHEREAS, the IGA directed the Cities to establish an airport governance structure in the nature of a commission to be called the "Northern Colorado Regional Airport Commission (the "Commission") and re-named the Airport as the Northern Colorado Regional Airport; and

WHEREAS, the IGA provides that the Commission shall be comprised of seven members as follows: (a) two members appointed by the Loveland City Council, who shall be City of Loveland council members or employees; (b) two members appointed by the Fort Collins City Council, who shall be City of Fort Collins council members or employees; (c) one Citizen Member appointed by the Loveland City Council; (d) one Citizen Member appointed by the Fort Collins City Council, and (e) one Joint Citizen Member appointed by both City Councils upon mutual agreement; and

WHEREAS, on June 4, 2019, City Council adopted on second reading Ordinance No. 071, 2019, approving the Second Amendment to the IGA, which modified the terms of the Citizen Members and Joint Appointed Citizen Member so that their terms are staggered and do not all expire on the same date, and providing that the Joint Citizen Member shall serve an initial term of four years commencing July 1, 2019, with each of the following terms to be four years; and

WHEREAS, the Airport Selection Committee, which was appointed by City Council, has recommended that Jerry Stooksbury be re-appointed as the Joint Citizen Member appointed jointly by the City of Fort Collins and the City of Loveland for a term of four years in accordance with the Second Amendment to the Airport IGA.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF FORT COLLINS, as follows:

- Section 1. That the City Council hereby makes and adopts the determinations and findings contained in the recitals set forth above.
- Section 2. That Jerry Stooksbury is hereby appointed to serve as the Joint Citizen Member the Northern Colorado Regional Airport Commission for a four-year term commencing immediately and ending at the end of June 30, 2023.
